
## **Current Situation**

#### Sweden is a NATO Ally

Since March 7

#### Statement Goals for Sweden:

- Growth
- Support to Ukraine
- NATO
  - Effort for all governmental agencies to review the impact of the NATO administrative rules and regulations, and any changes/updates needed on our side.
  - New demands and opportunities as a full member being part of the formal processes







## **Investigation of NATO governing CIS related Documents**

Purpose is to guide the Swedish stakeholders in approaching NATO steering documentation within the area of CIS

We retrieved NATO CIS related documents, from strategic concepts to implementing directives, from multiple sources.

The result is a collection and mapping of NATO governing CIS related documents and a first assessment on how these documents affect development in Sweden and the integration of Armed Forces into NATO.

- Further analysis of CIS related NATO documentation to prioritise interoperability and integration with NATO and Allies.






# **Multinational Capability Development Campaign**

The Multinational Capability Development Campaign (MCDC) series is an initiative led by the United States designed to collaboratively develop and assess concepts and capabilities to address the challenges associated with conducting joint, multinational and coalition operations.



**Development Campaign** 

It aligns under NATO ACT (Allied Command Transformation) and it started 2013.




- **Multi-domain.** The condition where two or more domains interact with one another.

## Multinational Multi-Domain Command and Control (M2C2)



This project will focus on existing Allied and Partner literature, development and acquisition actions, and doctrinal developments regarding C2 interoperability.

The complexity and speed of action is increasing in the battlespace, and the relevance, accuracy, and speed of coalition C2 must also increase. This requires that nations address Multi-domain C2 interoperability requirements and solution options with new approaches for achieving information and decision advantage across international standardization and harmonization of data and information systems based on data-centric security. Since C2 is not only a technological endeavor the military should also provide suitable organizational structures and focus on creating a cohesive mindset for future leaders.



  - Cooperation between Government Agencies







## International IOEs (Interoperability Evaluation)


#### **Last year:**






